10-CR-17-1204 STATEMENT OF PROBABLE CAUSE

Filed in First Judicial District Court 11/21/2017 11:44:12 AM Carver County, MN

The Complainant states that the following facts establish probable cause:

On Saturday, November 18, 2017, at approximately 5:40 p.m., Carver County deputies were dispatched to a single home residence located at 240 South Birch Street, in the City of Waconia, County of Carver, regarding an adult male who suffered a stab wound to the chest.

Upon arrival, deputies located an adult male, Michael Alan Gilster, supine on his back just inside the residence. Mr. Gilster's shirt was soaked with blood. Mr. Gilster was having trouble breathing, could not walk, and stated that he thought he was going to die. Deputies administered pressure on the stab wound to slow the bleeding until paramedics could arrive. Mr. Gilster asked deputies multiple times if he was going to die.

Paramedics arrived a short time later and Mr. Gilster was treated for a collapsed lung and internal bleeding at Ridgeview Hospital Emergency Room. Following initial treatment, Mr. Gilster was transported to the Hennepin County Medical Center.

While waiting for the ambulance, Mr. Gilster indicated that "Brandi" had stabbed him but he did not know where Brandi had gone after he was stabbed.

Following medical treatment, Mr. Gilster explained that he has been married to Brandi Jo Gilster, hereafter referred to as the Defendant for the past twenty-two years. Mr. Gilster indicated that the Defendant was an "angry alcoholic." Mr. Gilster stated that the Defendant was drunk when he got home on Saturday. Following an argument about the Defendant's drinking and behavior, he locked himself in his bedroom as he commonly did when the Defendant was drunk. However, because the Defendant then threatened to slash his tires, he went outside to prevent the Defendant from slashing his tires. Once outside, he found her sitting in his car with his car door open. The Defendant then got out of the car and there was a brief argument during which the Defendant said, "I really want to stab you right now." Mr. Gilster replied, "Go for it." The Defendant was holding a silver knife in her right hand and then immediately stabbed Mr. Gilster in the chest. The Defendant removed the knife, did not say anything further, and went back into the house.

In securing the residence, deputies located a black handled knife with a six-inch stainless steel blade. It appeared that the blade had blood on it, and that some of the blood had been wiped off.

The Defendant did not respond to commands to present herself. A number of deputies along with a Hennepin County Sheriff's K-9 unit and Minnesota State Troopers deployed to search the premises and surrounding neighborhood. Following a search, the Defendant was ultimately located at the rear of the yard where she was placed under arrest.

The Defendant smelled strongly of alcohol upon her arrest. The Defendant agreed to give a statement. In part, she admitted to having a knife because she was cleaning a marijuana pipe. She agreed that she did stab Mr. Gilster but said, "I didn't ever think it would actually go in."
