Registrants Among Us

 Registrants and those with a history of sex offending have always lived in our communities

• It's likely they live, work, and interact in every community in Minnesota



Registration

Established July 1, 1991

Administered by the MN Bureau of Criminal Apprehension (BCA)

Contents of registration:

- Addresses
- Employment
- School/vocation
- Vehicles

Registration

Registration is required if an individual is convicted, charged, or adjudicated delinquent for specific crimes:

- Criminal Sexual Conduct
- Any sexual conduct involving a minor including possession of child pornography.
- Kidnapping
- False Imprisonment

Registration

As of January 1, 2018, there were approximately **17,644** people required to register in Minnesota

- As of February 20, 2018:
 - 75 registrants in Carver County 98,741
 - 2554 registrants in Hennepin County 1.223 mil
 - 174 registrants in Scott County 141,660

Community Notification

- Established January 1, 1997
- Minn. Stat. § 244.052

Community Notification

Applies to:

- Registrants released from prison
- Registrants from other states or federal jurisdiction who were released from prison (including military)
- Those civilly committed for sexual offense behavior

Does not apply to:

- Those with juvenile registration offense only
- Registrants sentenced to probation only

Community Notification

Department of Corrections

• Responsible for assessing risk and assigning risk levels

Law Enforcement

- Responsible for community notification
 - Scope of notification based on assigned risk level

Risk Levels

- Level 1—Lower Risk
 - -Law enforcement may notify other law enforcement agencies
 - -Law enforcement shall notify victims and witnesses of the offense
 - -Law enforcement shall notify adult household members


Risk Levels

- Level 2—Moderate Risk
 - -In addition to Level 1 notifications, law enforcement may notify individuals or organizations based on the registrant's particular offense pattern or history

Risk Levels

- Level 3—Higher Risk
 - -Broad public notification/disclosure
 - DOC public registrant website
 - Public notification meeting
 - Media (newspaper, radio, television, etc.)
 - Agency website
 - Social media
 - Door-to-door flyers


Current Risk Levels




Those subject to broad public disclosure

• As of February 20, 2018, there were **384** registrants subject to broad public disclosure residing in Minnesota communities

Age of Victims









Adult convictions for False Imprisonment/Criminal Sexual Conduct involving adult female victims

Chemical abuse

2007, GM Indecent Exposure, Scott County

- Sexual conduct with adult female victim included exposing himself in a public place
- Gained access as victim was employee where offender patronized business
- Not known to victim although she had seen him before
- Disposition
 - 365 days jail, stayed, 2 years probation

2009, Criminal Sexual Conduct 4th Degree, Criminal Sexual Conduct 5th Degree, and False Imprisonment, Carver County

- Sexual contact with 21 year old female victim included sexual touching
- Gained access by asking victim for a ride
- Held victim against her will in her vehicle
- Known to victim
- Disposition
 - 2 years, 6 months prison

05/19/2009 entered prison

08/16/2010 release as level 2

Has returned to prison for supervision violations and Failure to Register convictions

04/18/2011 release as level 3

02/21/2018 release to Carver County

Supervision and registration requirements

• Mr. Zimmermann is under correctional supervision until 02/15/2028

• He is required to register until 02/13/2043

MN Statutes 244.12-244.15 (1990)

Primary Objective is Public Safety

Highly structured intensive form of supervision

Reduced caseload per agent allows more time with client

ISR provides a structured environment

- ✓ Individuals are held strictly accountable
- ✓ Compliance with release conditions
- ✓ Successful reintegration to the community
- ✓ISR operates night and day, weekends and holidays, 24/7, 365 days a year

• Elements

House arrest

Electronic monitoring

Random drug/alcohol testing

Unannounced residential/work contacts

Strict schedules

Daily check-in

Treatment-Chemical Dependency and Sex Offender

Conditions of Release

- ✓ No sexually explicit materials
- ✓ No contact with victim(s)
- ✓ No alcohol/illicit substances
- ✓ Obtain/maintain full time approved schedule
- ✓ No or monitored/restricted use of Internet



Community Transition

Minnesota law permits those released from prison to live in the community

Including:

Work, training, treatment

Shopping, laundry, church, medical care

Live free from harassment

Public can assist in monitoring behavior and activities, where appropriate

Stability contributes to control of offense cycle

Suspicious Behavior

Dial 911 to report suspicious behavior

Focus on Behavior

- Youth have image in their head of a "stranger"
- Mixed Messages



- We want children and teens to know how to ask for help. They should be taught HOW to talk to strangers.
- Children and Teens are much more likely to be victimized by someone they know





Two Questions

Does this person try to get me to break my safety rules?

Does this person give me an uh-oh feeling?











Lures

REALITY: Children and teen are most often lured by attention and affection.

Victims in sex crimes committed by people they met through the Internet were primarily 13-15 year old girls (75%). Half of the Victims were described as being in love or having close bonds with the offender.

What do I say to the children?


This is UNCOMFORTABLE...

- Teachable moments for kids and parents WHAT IF
- Identify at least FIVE Trusted Adults
- Upbeat. Positive.
- Not "THE TALK" but lots of little talks. You don't have to cover everything all at once.

 - 90% known to victim
 - 90% not previously convicted
- And the Two R's
 - It's about *relationship* not *residence*
 - Social proximity is more important than geographic proximity
