- 4. Guest Speaker: Dr. Richard Scott, Carver County Public Health Manager, and his team

are doing a survey of health issues in Carver County, targeted to specific groups and otherwise.

He brought along a short survey and asked those who agreed to do so to participate.

5. Derek appeared before a recent Carver County Board meeting and highlighted several

mental health issues: transportation, shortage of beds, and affordable housing. Following

his presentation, an article by Heather Hollermann, "County discusses mental health - Advisory chair outlines vision for program," was published in the August 2, 2018, issue of the Waconia Patriot. Commissioner Tim Lynch serves as our Advisory Council liason.

Commissioners were invited to attend our September Listening Session.

6. New Business: Melissa Hanson spoke on the AMHI/CSP (Adult Mental Health Initiative/

Community Support Program) grant application and asked the council to identify the top

seven service needs and barriers. Based on our responses, number one is lack of knowledge

of services, followed by lack of psychiatrists, long wait times, stigma.

Mary Myss suggested offering a class through Community Education as a mental health resource.

At present Carver County does not have an IRTS (Intensive Residential Treatment Services)

facility. These are for individuals not in crisis but needing 30 to 90 days of treatment beyond

hospitalization, thus helping decrease frequency of repetitive hospitalizations.

Maximum

number of beds is 16.

Mary asked why grant money is not used to reimburse therapist travel to patient. Scott

County has a mobile clinic. Home therapy for adults is also done in the Twin Cities.

7. Old Business: September 11, 2018, meeting moved to the Chanhassen Library. LAC meeting from 4:30 - 5:30 p.m. Listening Session from 5:30 - 7:30 p.m. Notices will be placed in Chanhassen, Chaska, Waconia, Victoria papers, Next Door, Facebook, social media.
