- 4. Guest Speakers from Carver County Health and Human Services Lindsay Juricek, Office of Aging Program Specialist Jill Willems, Home & Community Based Care Department Supervisor Their roles overlap in working with seniors and our aging population. They gave us

excellent information:

Dementia is defined as a broad category of brain diseases causing cognitive changes within the brain.

Included within the definition are Alzheimers, Lewy Body, Parkinsons. Specialists are

diagnosing Alzheimers with a 90% accuracy rate; this formerly could be

done only on autopsy.

Schizophrenia is seen early and late in life. Patients who can communicate, who still have verbal skills, can be helpful in treatment of their disease.

Jill handed out flyers highlighting the work of TRIAD, a partnership of law enforcement, the public and senior citizens, designed to keep our seniors safe.

Sandy Menzel asked whether programs are available to help support caregivers. Chanhassen is the first community in the country to become dementia friendly. Program was started in the UK. Every police officer in Chan has been trained in dementia friendly response. Supported by faith-based community at present. Host various programs. Hoping to receive a grant to hire a Master Social Worker. Other programs are Encore Adult Support in Waconia, Sojourn in Chaska and Eden Prairie. Ridgeview is resurrecting some support groups for people with dementia.

Question on affordable housing. Staffing a problem as well as funding. Watertown

looking at funding for senior/family friendly housing. Norwood/Young America has

a lot of senior housing but affordability is a problem. Carver County is healthiest and

we althiest county, however 12,000 people here live in poverty.

Poverty seen as a

county gap. Barriers because of "not in my backyard."

Mary Myss said we need to encourage financial incentives for family caregivers so they can keep their senior loved ones at home.

Folks in eastern Carver County have better access to healthcare

opportunities.

Needs in Carver County for assisted living and memory care. People with severe mental health disorders are at higher risk for developing dementia. Those with dementia at higher risk for developing depression.
