Agenda Item 1:	Call to Order: Derek seconded by Sandy	
Agenda Item 2:	Approve Agenda: The motion was made to approve the September agenda, and was seconded. Derek requested the addition of information on Rural Mental Health, which was approved by all.	Approved by consensus

#### Agenda Item 4:

**New Business:** Derek mentioned that the letter to the editor regarding suggestions from last meeting was still being worked on.

Rural Mental Health—Jen informed group that she spoke with Ted Mathews who provides mental health counseling for farm/rural families. He is a psychologist and is not only the only one in Minnesota but the only one across the country. He offices out of Hutchinson but travels extensively and looks for space in the communities to meet with clients. Some of the issues are stress, depression, transferring farms to next generation, losing farm and couples stress with one working outside and inside to help sustain and all the stress involved in that. More women are getting into farming so they are training a woman to do outreach. The group in general wants to know how our council/county might be supportive of these efforts. Jen will be asking him to present to the group --- possibly in November.

Melanie commented that the Crisis team has been doing more outreach and training on rural mental health issues.

#### Agenda Item 5:

### **Chair Reports:**

AMHI meeting --- report on Vitals. Chief Knight reported that Chaska has been using vitals for 2 years and has yielded 300+ encounters or "pings" --- but they have not been significant incidents but more commonly officers at an event or in the community public setting. Officers use their discretion as to whether they approach someone if they seem to be in need. Council members expressed some concerns about using Vitals in this manner to possible identify and approach someone who is not directly asking or needing response. Derek reminded them that it is voluntary. The question on the table was, "would they approach someone without the prompt form the system?" It might be helpful in some cases but brings up concerns about stigma and over identification of citizens with mental health issues. Comment that this speaks to the need for careful and thoughtful training of personnel using this system.

Derek commented that the Sheriff wants to look at it more closely. It was learned from the presentation by Chris Kokal that NAMI - MN does not endorse the system.

Derek – CDA wants to have a homeless event and is asking the council to support this initiative. A fund raising sleep out in the community is scheduled in November --- members felt it was a worthy cause. The speaker will be addressing more specifics.

A "sleep out" is scheduled for November 16<sup>th</sup> to raise funds and is looking for community support. In Carver County, \$25,000 has been spent to assist people with homelessness prevention. Goal is to have 100 participants in the Sleep-Out. Food trucks, a band, scavenger hunt for youth, etc. are being planned. All of the proceeds will go to supporting people experiencing homelessness, including assistance with medical, rental and utility bills, car repairs, etc. Martha commented that many people who are homeless have mental health issues.
