BACKGROUND/JUSTIFICATION:										
Mailbox Policy Carver County has adopted a resolution that established a mailbox policy (unknown date) and a program to eliminate hazardous mailboxes. Since that time, the actual practices of the Division have changed enough to warrant an update to the mailbox policy. The mailbox policy follows state statute and rules to the extent possible, except that the speed limit of 40 mph is reduced to 30 mph or greater for the requirement of safety mailbox supports. Staff will give a presentation on the draft policy to the county board and would appreciate comments. Drain Tile Policy Carver County has adopted a resolution that established a tile policy (unknown date). Since that time, the actual practices of the Division have changed enough to warrant an update to the drain tile policy and to include additional provisions. The drain tile policy follows state statute and rules to the extent possible, whether it is a public or private drain tile conveyance system. Staff will give a presentation on the draft policy to the county board and would appreciate comments. Landscape Policy Carver County currently does not have an adopted landscape (or streetscape) policy. Carver County Public Works has been receiving requests from the local cities to install landscaping features within county highway rights-of-way. Most of the requests have been associated with concurrent construction or reconstruction projects that are being jointly undertaken by the county and the local city. A draft Landscape Policy has been developed to assist Public Works staff in consistently applying a landscape policy that will accommodate some landscaping features that meet the established criteria and guidelines. Staff will a presentation on the draft policy to the county board and would appreciate comments.
