The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

Charge Description: On or about May 8, 2021, within the County of Carver, State of Minnesota, defendant caused the death of a human being with intent to effect the death of that person or another, but without premeditation.

STATEMENT OF PROBABLE CAUSE

The Complainant states that the following facts establish probable cause:

On Saturday, May 8, 2021, at approximately 2:20 p.m., Carver County Deputies were dispatched to 3732 Landings Drive in Chanhassen, Carver County, Minnesota, regarding a fire alarm. While responding, the Carver County dispatcher received a subsequent call within minutes indicating there had been a shooting at this residence. As of May 8, the current residents of 3732 Landings Drive were Paul Ness, Alyssa Ness, and their two adult children, Noelle and Joseph Ness.

This subsequent 911 call regarding the shooting was placed by a nearby neighbor after Alyssa Ness had run to this neighbor's home exclaiming, "Joey shot and killed Noelle." As a number of deputies were responding, one deputy stopped at this neighbor's house to meet with Alyssa Ness, noting that Alyssa Ness was distraught. However, Alyssa Ness repeated that her son had shot her daughter and that there were multiple weapons in the house. Alyssa did not currently know whether her son still remained in the house.

At approximately, 3:05 p.m., a different homeowner, approximately a half-mile north of the Ness residence in Hennepin County, called 911 stating that a white male had walked onto her property from the public trail that bordered her property. This neighbor indicated that the male, later identified as Joseph Ness, and hereafter referred to as the Defendant, stated, "Please help me. I need your help. I need you to call the police for me. I just killed my sister. I want to surrender peacefully. I am unarmed." Although startled by the encounter, this second neighbor then called 911. Deputies soon arrived and took the Defendant into custody without further incident at approximately 3:15 p.m.

Deputies subsequently entered the residence of 3732 Landings Drive. Upon entering, deputies noted hundreds of spent rifle casings, bullet holes in walls, and many windows shattered by gunfire. Further examination revealed that the Defendant had shot, in part, from his bedroom into Noelle Ness's bedroom across a hallway, those rounds travelling in largely a horizontal manner. Next, it appears Noelle may have been shot at a closer range as rounds travelled vertically through her bed and some of her wounds had stippling. 12 spent rifle casings were recovered near her bed. Paramedics arrived at the scene and pronounced Noelle dead. In the execution of a subsequent search warrant, six rifles, ammunition, and high-capacity drum magazines were seized. These rifles included AR-15 and AK-47 variants.

Please note that the information in this complaint is preliminary. The Carver County Sheriff's Office and the Minnesota Bureau of Criminal Apprehension continues with the investigation. In addition, the Midwest Medical Examiner's Office will submit a full autopsy report.

The State reserves the right to amend the complaint and charges as may be allowed by the Minnesota Rules of Criminal Procedure.

PLEASE TAKE NOTICE: Pursuant to Minn. Stat. 609.49., intentional failure to appear for duly scheduled court appearances may result in additional criminal charges, and in addition to any arrest warrant that may otherwise be issued by the Court.
