A Regular Session of the Carver County Board of Commissioners was held in the County Government Center, Chaska, on April 24, 2012. Chair James Ische convened the session at 9:06 a.m.

Members present: James Ische, Chair, Gayle Degler, Vice Chair, Tim Lynch, Randy Maluchnik and Tom Workman.

Members absent: None.

Degler moved, Lynch seconded, to approve the agenda. Motion carried unanimously.

Maluchnik moved, Workman seconded, to approve the minutes of the April 17, 2012, Regular Session. Motion carried unanimously.

Community announcements were made by the Board.

Degler moved, Lynch seconded, to approve the following consent agenda items:

Agreement for lifeguard services with Minnetonka School District and authorized the Chair and Administrator to sign the agreement.

Deleted a .5 FTE social worker I and created a .5 FTE social worker II position.

Approved creating a temporary employment counselor position for the May 14-August 17, 2012, time period, not to exceed 520 hours.

Professional services agreement with SRF Consulting Group, Inc. and authorized the Chair and Administrator to sign the agreement.

Authorized the Sheriff's attendance at the National Sheriff's Conference in Nashville, Tennessee.

Approved joint powers agreement with the DNR; approve grant agreement with Minnehaha Creek Watershed District, related budget amendment for the 2012 AIS pilot program at Lake Minnewashta Regional Park and accepted the \$1,000 donation from the Lake Minnewashta Preservation Association to be used for the AIS program.

Approved the agreement and restrictive covenant with the Metropolitan Council and authorized the Chair to sign the agreement.

Resolution #26-12, Revising Non-Bargaining Salary Ranges and Setting Non-Bargaining Employee Salary Rates, Effective July 2, 2012.

Authorized Assistant County Attorney attending National District Attorney's Association Southwest Border Prosecution initiative training in San Antonio, Texas, with expenses to be paid by NDAA.

Community Social Services' actions.

Approved payment of the following Commissioners' warrants:

Motion carried unanimously.

Lynch moved, Workman seconded, to open the public hearing on the redistricting of Carver County Commissioner Districts. Motion carried unanimously.

Mark Lundgren, Taxpayer Services, reviewed the timeline leading to the redistricting plans. He stated an informational meeting was held for the public and advertised in all five County newspapers. He noted at the Board's April 17th work session plans were presented and he will be asking the Board to continue today's public hearing until next week for a final decision.

He stated no plans from the public were presented. Lundgren entered into the record City of Carver's Resolution No. 116-12.

Lundgren clarified five Commissioner Districts are required. He stated staggered terms are also required, with two Districts having two year terms and three Districts with four year terms.

Lundgren stated there were a number of "islands" created within city limits as a result of annexation which caused limitations and "married" precincts. He pointed out there were more redistricting options for redistricting the east vs. the west and highlighted the two main options for the west.

Jennifer Tichey, Assistant County Attorney, reviewed the primary legal requirements the Board must consider when redistricting. She stated that a plan should be as nearly equal in population as possible and not vary in population more than 10% from the average population for all commissioner districts in the county. She clarified that this requirement may be modified by the obligation to avoid splitting a voting precinct. She stated the district must be bounded by township, municipality, ward or precinct lines and be composed of contiguous territory and clarified contiguous means it needs to be adjoining. She also noted the requirement that districts are as regular and compact as far as practicable.

Tichey identified other considerations to keep in mind including communities of interest with similar economic, cultural, political, urban/rural and population trends. She stated the Board had the duty to adopt a plan that best serves the needs of the County and meets the statutory requirements. Tichey suggested the Board articulate their reasons for adopting or rejecting a plan. She stated Statute allows voters to challenge the plan and reviewed various remedies the Court could order.

Jim Burns, Hollywood Township, stated he was a Hollywood Township Supervisor and had reviewed the plan options. He stated Hollywood Township has concerns with any plan that include a large Commissioner District geographic area such as options that have Hollywood Township and the City of Carver in one district. He requested they take communities of interest into strong consideration. Burns stated Hollywood Township deals with different issues than the City of Carver. He raised his concern with a District that covers three sides of the County and the amount of miles

between Hollywood Township and City of Carver. He stated it was important to have access to their Commissioner on a regular basis and with that large of a district it would be difficult to ensure Commissioner attendance at their annual meeting. Burns added Hollywood Township was planning a special meeting this Thursday to get input from their residents and hope to present a Resolution to the County Board before their next meeting.

Chair Ische acknowledged they had 25 plans to consider and suggested they review each of them to determine which of the plans they may want to consider further next week. Lundgren clarified they have 24 plans to consider and that plan 25 was created to illustrate current commissioner boundaries to the new precinct/ward lines.

Chair Ische asked for additional public comments but none was received.

Lynch moved, Degler seconded, to continue the public hearing to 9:00 a.m. May 1, 2012. Motion carried unanimously.

Maluchnik raised the issues brought forward by Mr. Burns related to certain plans not being regular and compact and the difficulty of a commissioner representing a District that large. He stated there was a community interest concern with Plan 1 but since this appeared to meet the other five criteria that Plan 1 should be included.

Workman recognized half of the plans slightly went over the 10% rule on the West side and requested legal clarification if these could be considered.

Tichey stated Statute does provide a somewhat broad exception to the 10% rule. She stated that a plan can go over the 10% rule to avoid splitting a voting precinct. She confirmed all of the proposed plans meet the statutory requirements and there are other factors the Board could consider when adopting a plan.

Degler stated concern related to the unintentional consequences of redistricting creating islands which married precincts to townships. Lundgren acknowledged there were restrictions caused by the islands and gave the example of the City of Mayer being married with Waconia Township.

Degler inquired on the future plans of the communities with the islands. Lundgren stated that his discussions with the cities indicate that these islands will be annexed in the near future.

Maluchnik stated Plan 2 should be included because it met the criteria and addresses the concerns of Hollywood Township and the City of Carver. He stated this plan is more compact even though it is slightly over the 10% deviation.

Workman raised concerns with Plans 3 and 4 with the District being spread over the Cities of Chaska, Chanhassen and Victoria and Maluchnik agreed with those concerns.

Maluchnik stated Plan 5 should not be considered in that it is not compact and regular and did not address the concerns of Hollywood Township and the City of Carver.

No comments from Board members on Plan 6 and it was laid aside.

Maluchnik stated Plan 7 had problems with compactness.

Plan 8 was laid aside for the same reasons.

Maluchnik stated Plan 9 had problems with Hollywood Township and the City of Carver being in the same district and was not compact.

Maluchnik stated Plan 10 had problems with Commissioner District 2 representing three cities and he agreed with Workman's earlier concerns. He noted the deviation was over 10% and Plan 10 should be set aside.

Maluchnik stated Plan 11 had the same problem with the City of Carver and Hollywood Township being in the same district and fails to meet the compactiveness test.

Degler noted the high deviation in Plan 12 and Maluchnik added that Plan 12 had multiple cities represented in one district.

Maluchnik stated Plan 13 had the same issues with Hollywood Township and the City of Carver being in the same district and did not meet the criteria of being compact and regular.

Degler stated Plans 13 and 14 had one commissioner representing three cities and should be set aside.

Maluchnik stated Plan 15 had the same problem with compactness in that district and should be set aside.

No comments on Plan 16 and the Board agreed to set aside.

Maluchnik stated 17 had the same problem with Hollywood Township and the City of Carver being in the same district and should be set aside.

No comments on Plan 18 and the plan was set aside.

Maluchnik stated Plan 19 was not compact and regular and difficult for a commissioner to cover that large of an area.

Degler stated plans 19 and 20 have one district covering three cities and should be eliminated.

Maluchnik stated Plan 21 was not regular and compact, difficult for one commissioner to represent and should be set aside.

Maluchnik suggested Plan 22 met all of the criteria and should be considered further but noted the population deviation concern.

Maluchnik stated Plan 23 had problems with Hollywood Township and the City of Carver being in the same district and was not compact and regular.

Maluchnik stated Plan 24 seemed to fit the criteria and should be further considered.

The Board agreed Plan 25 was not statutorily compliant.

Chair Ische requested a motion to consider plans for future review at their next meeting and ask for additional public comment on the plans.

Maluchnik moved, Degler seconded, to consider Plans 1, 2, 22 and 24 for further review during their May 1st meeting. Motion carried unanimously.

Martin Walsh, Parks, requested the Board award a contract for the Lake Minnewashta Regional Park and TH 41 Trail and Underpass project. He stated the Lake Minnewashta Park Plan was revised in 2002 and recognized traffic on 41 as a barrier. He explained part of that plan recognized the need for a trail on the East side of 41 and underpass. Walsh indicated they applied for a grant in 2007 and were successful in obtaining one million.

He identified the project scope and area. He stated they did enter into a joint powers agreement with the City of Chanhassen on cost sharing. He reviewed the projects costs and three factors that increased the cost. Walsh pointed out the timeline for the construction and clarified they would not close 41 until traffic opens on Highway 5. He also noted the trail entrance to the park would not be located near the main Park access due to the topography of the area.

Workman moved, Degler seconded, to award a contract to Rosti Construction Company of Minnesota, Inc., to construct the TH 41 and Lake Minnewashta Regional Park Trail and Underpass and authorize the Chair to sign the contract. Motion carried unanimously.

Degler moved, Lynch seconded, to go into closed session at 10:15 a.m. to discuss labor negotiations strategies. Motion carried unanimously.

The Board adjourned the closed session and Regular Session at 10:55 a.m.







WHEREAS, said application was duly considered at a public hearing held by the Carver County Planning Commission at its regular meeting of April 17, 2012; and,

WHEREAS, the Carver County Planning Commission finds as follows:

- Jane Zimmermann owns and homesteads 10.03 acres located in the NW ¼ of the SE ¼ in Section 20 of Dahlgren Township. The property is improved with an existing home with an attached garage, detached garage, several outbuildings and grazing pasture. The site is located within the Agriculture Zoning District and the CCWMO – Bevens Creek.
- 2. The applicant is requesting a Conditional Use Permit (CUP) for a barn with an attached indoor riding arena for personal use pursuant to Section 152.079 C5 of the Carver County Code.
- 3. The proposed 36 x 36 foot barn would include four stalls for their two horses and a 60 x 90 foot attached indoor arena for personal use. The existing storage shed will continue to be used for hay and shavings.
- 4. The applicant has an agreement with the neighbor to the north and west to remove horse manure from her property in the spring and fall.
- 5. The proposed location meets all setback requirements and shall not impact the existing subsurface sewage treatment system or well on the property.
- 6. The Dahlgren Town Board has reviewed the request at their March 12, 2012, Town Board meeting and recommended approval.

THEREFORE, BE IT RESOLVED, THAT The Carver County Planning Commission hereby recommends the issuance of Conditional Use Permit #PZ20120011 for an Equestrian Facility/Indoor Arena on the land described in Exhibit "A" of the permit application. The Planning Commission further recommends that the following conditions be attached to the permit:

- 1. The permit is subject to administrative review. A change in ownership, operations, operator, or occupancy of the residence shall be cause for the permit to be reviewed by Land Management for a determination as to whether an application for an amendment or similar consideration is necessary. Proposed owners/operators are encouraged to contact Land Management as early on in the timeline of the proposed change as possible.
- 2. The Permittee shall obtain all necessary building and septic permits prior to the construction of the proposed building. All structures shall meet the applicable State Building Code requirements.
- 3. The Permittee shall comply at all times with the County standards as detailed in Chapter 54-Feedlot Management requirements and/or appropriate permit(s) required by the Environmental Services Department.



WHEREAS, said application was duly considered at a public hearing held by the Carver County Planning Commission at its regular meeting of April 17, 2012; and,

WHEREAS, the Carver County Planning Commission finds as follows:

- Xcel Energy is planning to construct an electrical substation off of Dahlgren Road, on the current Wm. Mueller & Sons, Inc. property, which is located in the Northeast Quarter (NE¹/₄) of the Northwest Quarter (NW¹/₄) of Section 24, Dahlgren Township. The property is located in the Transition Area Overlay District (City of Carver) and the CCWMO – Carver Creek watershed.
- 2. The applicant, Brian Mielke, is requesting a Conditional Use Permit (CUP) for an electrical substation, which is classified as an essential service by the County Zoning Code. Xcel Energy has a purchase option agreement with Wm. Mueller & Sons for the proposed 4.55 acre parcel. The development of the new "Dahlgren Substation" is necessary to continue service to the City of Carver load.
- 3. Public Utility Structures (such as substations) are allowed in all Districts, as a conditional use, pursuant to Sections 152.050 through 152.053 and Section 152.055 of the Carver County Code.
- 4. The applicant's narrative and site plan(s) address the specifications and site considerations for the proposed facility. The new substation would replace an existing one in Chaska that will be removed from service in 2013. The proposed location would allow for an efficient connection to an existing transmission line. The proposal appears to meet the standards of the Zoning Code. The site selection, road access, grading/drainage, landscaping/screening, environmental, and security considerations have all been addressed in the applicant's submittal.
- 5. The County Planning & Water Department has reviewed the preliminary grading and drainage plan. The stormwater management plan would be considered a Level 2 development review because the impervious area would be less than 1 acre. The plan would incorporate an appropriate infiltration basin and emergency overflow outlet for the site.
- 6. Traffic would be minimal, generating no more than two to four trips per week once the facility is operational. Dahlgren Township is the road authority; however, only minimal upgrading of the existing field access would be required. Wm. Mueller & Sons would continue to use the driveway sporadically.

7. The site plan indicates a security fence around the substation which meets or exceeds the required setback standards.

Fences exceeding six (6) feet in height may be constructed only after the issuance of a permit as provided in the State Building Code. Warning signs would be posted to alert the public to the potential dangers of unauthorized entry.

- 8. The applicant is planning to address landscaping and screening with wood fencing and by planting conifers and shrubs on the north and west perimeter of the property. The existing trees and vegetation along the east side of the property will remain in order to help screen from that direction. There are some constraints in the maximum height of the trees because of the overhead transmission lines. Berms will also be incorporated, providing drainage control and aesthetics to the site.
- 9. Pending approval of the request, the applicant will be required to apply for a Minor Subdivision to create the new parcel. Absent a CUP, there would not be a reasonable use for the property in order to create a new parcel of this size.
- 10. The City of Carver has reviewed and commented on the proposal, with no objections. Cindy Nash, of Collaborative Planning, LLC has submitted a letter, dated April 10, 2012, on behalf of the City.
- 11. The Dahlgren Town Board reviewed the request at their February 13, 2012 Town Board meeting and has recommended approval.

THEREFORE, BE IT RESOLVED, THAT The Carver County Planning Commission hereby recommends the issuance of Conditional Use Permit #PZ20120009 for an Electrical Substation on the land described in Exhibit "A" of the permit application. The Planning Commission further recommends that the following conditions be attached to the permit:

- 1. The permit is subject to administrative review. A change in ownership, operations or operator shall be cause for the permit to be reviewed by Land Management for a determination as to whether an application for an amendment or similar consideration is necessary. Proposed owners and/or operators are encouraged to contact Land Management as early on in the timeline of the proposed change as possible.
- 2. The location plan (dated: 3/13/12) and operational narrative (dated: 3/9/12) shall be attached to and become part of the permit. The development of the facility shall be substantially in accordance with the submitted plans, including the contour and grading layout and landscape layout.
- 3. A Minor Subdivision application shall be submitted and approved by Carver County Land Management prior to the recording of any deed(s).
- 4. Permittee.shall comply with the Water Resource Management standards, pursuant to Chapter 153 of the County Code. Prior to any construction activities, an application for Water Management Rules Conformance and Approval would be required.
- 5. Permittee shall comply with the road authority's requirements regarding the access and/or any work within the existing road right-of-way.
- 6. The property including the structure(s) and grounds shall be maintained in a neat and orderly manner.
- 7. The substation shall be secured from the public by means of a fence and shall not create a potential public hazard. An appropriate building permit(s) shall be obtained for the perimeter fencing and any other structures subject to the State Building Code.

WHEREAS, pursuant to these statutes and the 2010 Federal Census population figures shall be used to redistrict the Carver County Commissioner Districts by May 1, 2012, and that Commissioner Districts shall be bounded by town, municipal, ward, city district, or precinct lines; and,

WHEREAS, Carver County published a three week notice in the newspaper having the contract for publishing the commissioner's proceedings for the county for 2012; and,

WHEREAS, Carver County conducted a public meeting on redistricting on April 24, 2012 and May 1, 2012; and

WHEREAS, based upon all the available data, various redistricting proposals have been considered by the county board; and

WHEREAS, Minnesota Statutes § 375.025, subd. 1 sets the following standards for county commissioner districts:

- Each county shall be divided into as many districts numbered consecutively as it has members of the county board;
- Commissioner districts shall be bounded by town, municipal, ward or precinct lines;
- Each district shall be composed of contiguous territory as regular and compact in form as practicable; depending upon geography of the county involved and shall be as nearly equal in population as possible;
- No district shall vary in population more than 10 percent from the average for all districts in the county, unless the result forces a voting precinct to be split;
- A majority of the least populous districts shall contain not less than a majority of the population of the county; and

WHEREAS, the county board also recognizes that an important consideration of a plan are to keep communities of interest as whole as possible; and

WHEREAS, the County Board has further determined that plan X:
