Commissioners Gayle Degler, John P. Fahey, Tim Lynch, Matt Udermann and Tom Workman met in session this day as required by law for organizational purposes for the year 2022.

The session was called to order by County Administrator, David Hemze, at 9:00 a.m. Hemze reviewed the nomination process for the Chair.

Udermann nominated Tom Workman to serve as Chair of the Board of Commissioners for 2022 with a rotating gavel so each District is equally represented over the span of five years.

Lynch nominated Gayle Degler to serve as Chair of the Board of Commissioners for 2022. Hearing no other nominations, Administrator Hemze closed nominations. On vote taken to elect Tom Workman to serve as Chair of the Board of Commissioners for 2022 with a rotating gavel by Commissioner District, Udermann, Workman voted aye. Degler, Fahey, Lynch voted nay. Motion failed.

On vote taken to elect Gayle Degler to serve as Chair of the Board of Commissioners for 2022, Degler, Fahey, Lynch voted aye. Udermann, Workman voted nay. Motion carried.

Chair Degler requested nominations for Vice Chair. Udermann nominated Tom Workman as Vice Chair of the Board of Commissioners for 2022

Lynch nominated John Fahey as Vice Chair of the Board of Commissioners for 2022.

On vote taken to elect Tom Workman as Vice Chair for 2022, Udermann voted aye. Degler, Fahey, Lynch, Workman voted nay. Motion failed. **On vote taken to elect John Fahey as Vice Chair for 2022, Degler, Fahey, Lynch, Workman voted aye.** Udermann voted nay. Motion carried.

The concern is also the amount paid to the Chair and Vice Chair.

So here we are 1997 - 2022 and still the covering up of Carver County and their power to abuse and the publics right to find out the truth.

So I want to make sure this is on public record and Commissioner *Lynch since 2004 you have been Dave Hemze cover up boy. Dave Hemze needs fools like you. He hit paydirt and you're on so many videos proving what a Hemze puppet you are. But at what cost to others, you do not care.*
