 - M. Walsh presented the 2023 Draft Operations & Maintenance Budget Request which provides details on anticipated revenue and expences. Revenue is expected to increase due to an increase in funding from the Met

Council and the CCRRA. Staffing related expences are expected to rise with new hires and department reorganization.

1. M. Walsh also reviewed the current draft of ongoing and one-time expenditure requests. The County Board will have final approval over these requests.

iii. Fee Schedule

- 1. S. Pertz gave an overview of the proposed changes to the 2023 Fee Schedule including new fees for the Waterfront Service Center, and revised fees for shelters, services, equipment rentals, and permitting.
- **b.** Summer Recreation Services Overview
 - i. S. Pertz reviewed a memo which details the summer outdoor recreation services and operations plan for the season. One issue that may arise is not being able to have lifegards for all shifts due to low staff levels.
- c. Emerald Ash Borer Management Plan
 - i. J. Sandvig has begun to inventory the count of ash trees on park property. Those selected to be treated, which are at least 10" in diameter, will be injected this year, and then again in 2024. Those smaller than 10", in poor health, or in unfavorable locations will be removed and replaced with other varieties of trees. Infected trees have not been found on park property yet, but are in other areas of the county.
- **d.** Waterfront Service Center Update (Information Provided at Meeting)
 - i. The bid package will be presented to the County Board on June 28th to give approval to award contracts. As of now, the all in cost for the project is \$8.7 million.
- 9) Staff Reports

 - i. S. Pertz thanked the local Lion's Chapters for their volunteer work on Coney Island. He also shared the recent summer postcard that was mailed out as well as the summer Program Guide and newspaper insert.

 - i. Trees should be treated in August for Emerald Ash Borer. Preparation has begun for 4th of July fireworks and activities. Seasonal employees are being trained in and will be working on projects throughout the season.

SUBJECT: Special Event Use Permit Request – United Healthcare Children's Foundation



This memorandum outlines the pertinent details for review and recommendation for issuance of a Special Event Use Permit to United Healthcare Children's Foundation. The permit allows for a bike ride/race event(s) as a means of fund raising, which is planned to occur on a portion of the Dakota Rail Regional Trail owned by Carver County.

United Healthcare Children's Foundation

- **Date(s):** Saturday, 8/13/22
- Where: Dakota Rail Regional Trail, between CR 10 and CR 155 (generally the north side of Lake Waconia)
- What: Endurance bike ride/race.
- **Attendance:** At least (100) participants are anticipated to ride this portion of the events overall route(s) layout.
- **Impact on DRT:** Event will bring increased users of the endurance biking demographic to this segment of the trail between 9-11am on event date. Staff do not see other impacts for the Park Commission to be aware of.
- Required Permit Items Obtained & Reviewed: Yes, process underway.
 - Required permitting materials were submitted recently, creating a less than ideal timeline to this
 permitting process. Staff are working to move the request forward, with the final step of County
 Board authorization planned for the August 2nd meeting.
- Significant Elements/Items of Attention: In the past, similar events have raised some concerns of
 adjacent private property owners along the DRT. The segment being requested for event use has not
 been an area of sensitivity.
- Permit Fees: Applicable fees per the 2022 County Fee Schedule special event use permit application.
- Years with County Issued Use Permit: This is the first year the organization has requested a SUP.
- Staff Notes: This event has light/minimal impacts/use on County Park and Trail property. The event group has also requested use of County Road ways and is working with Program Delivery on those permit requirements.

Recommendation: It is requested that the Park Commission recommend issuance of a Special Event Use Permit to United Healthcare Children's Foundation to the County Board upon completion of all outstanding items.
