The last two years of LAC meeting minutes were reviewed to drive subgroup focus; Kelli met with Scott Co and Hennepin Co LAC representatives as well to gather information.</p> <p>b) Discussion of subgroups and potential of additional stipend: Melissa shared that an additional stipend cannot be provided for subgroup meeting attendance with only a few members in attendance but can be provided for a full LAC meeting/event. Discussion of potential request for additional funding in future.</p> <p>c) Community Health Assessment (CHA) every five years – structure for regular feedback. The LAC will complete an annual needs assessment, and this year will partner with Carver County Public Health as the CHA is being completed.</p> <p>d) Representatives for subgroups with the following focus were discussed: 1) Upcoming Events and NAMI Connection, 2) Mental Health Needs Assessment/survey input (coordinated with Melissa Hanson and Pat Stieg) to support the report to the County Board of Commissioners and the AMHI Grant, 3) Legislative action and local impact updates, 4) Community Connection (coordinate with local nonprofits and religious organizations, Heather and Kai Tran), 5) Eastern Carver County School connection (Tara Cliff, Kelli Brenny, Stigma 180), and Create a Carver County Handbook with updated bylaws and adding youth representative (proposed mission/vision attached).</p> <p>e) The last presentation for the County Board on August 2, 2022 was discussed; technological difficulty with sound so was not reviewed during meeting.
