# Very Small Quantity Generator (VSQG) Program

---

## Who Qualifies?

- **Carver County businesses that generate hazardous waste, but less than 220 lbs. or about 22 gallons per month. No hazardous waste is accepted from businesses outside of Carver County.**

## How do you Participate? 3 Steps.

### 1. Identify your wastes and fill out the attached inventory form.

- Include your EPA Hazardous Waste Generator ID.
- If your organization does not have an ID number, or is unsure, county staff can assist you in finding yours or applying for one.
- Fill out the waste inventory form including the type or name of the waste, total number of containers and volume.
- If contents of a container are unknown please list as much information as possible.
- Do not bring unknowns without prior approval from county staff.

### 2. Email completed form to: [mtnelson@carvercountymn.gov](mailto:mtnelson@carvercountymn.gov)

- County staff will contact you with any questions after reviewing your application.
- After your application is accepted, you will be contacted to schedule an appointment.
- **Business waste is not accepted without an appointment.**

### 3. At the time of your appointment transport your waste to:

- All containers must be labeled and in good condition.
- Leaking containers will not be accepted.
- Information on safely, responsibly and legally transporting your waste can be provided to you prior to your appointment.
- Carver County reserves the right to refuse any wastes not transported according to MNDOT requirements.
- Payment is required at time of delivery: Cash, card or check are accepted.
- Make checks payable to: Carver County

## Universal Waste

The Carver County Environmental Center accepts universal waste such as electronics, fluorescent lamps and batteries. If your business is only disposing of universal waste an appointment may not be needed but please call ahead so that appropriate preparations can be made. There are disposal fees associated with universal waste from businesses. Some items may be priced on a case by case basis.

Less than 4' straight..... \$0.40/each  
Over 4' straight.....\$0.75/each  
CFL.....\$0.60/each  
HID.....\$2.30/each  
Irregular Shape.....\$1.00/each  
Broken.....\$2.14/each  
Super High Pressure Hg..... \$12.00/each

Most Electronics..... \$0.50/lb.  
Mercury Devices..... \$32.16/lb.  
Ballasts.....\$0.99/lb.  
Lead Acid Batteries..... Free  
Other Battery Chemistries.....\$0.38/lb.
