David Hemze County Administrator A Regular Session of the Carver County Board of Commissioners was held in the County Government Center, Chaska, on March 14, 2006. Chair James Ische convened the session at 9:00 a.m.

Members present: James Ische, Chair, Gary Delaney, Vice Chair, Gayle Degler, Tim Lynch and Tom Workman.

Members absent: None.

Degler moved, Lynch seconded, to approve the agenda. Motion carried unanimously.

Delaney moved, Workman seconded, to approve the minutes of the February 28, 2006, Regular Session Motion carried unanimously.

Under public participation, Carlos Gallego, stated he had attended a recent meeting where the issue of a centralized purchasing system came up and inquired on the advantages. Chair Ische directed that the County Administrator contact Mr. Gallego and respond to his inquiry.

Community announcements were made by the Board.

Degler moved, Delaney seconded, to approve the following consent agenda items:

Motion carried unanimously.

Workman moved, Degler seconded, to recess as the County Board and convene as Joint Ditch #1 Authority. Motion carried unanimously.

Mark Lundgren, Auditor, reviewed the request for clean on Joint Ditch #1 in Hollywood Township. He indicated he contacted McLeod County representatives and he has heard no objections. He estimated a cost of \$9,600 to clean out 4,500 feet and noted all work would be done in Carver County.

Degler moved, Lynch seconded, to approve clean out of Joint Ditch #1 at a cost estimate of \$9,600. Motion carried unanimously.

Lynch moved, Degler seconded, to adjourn as the Joint Ditch #1 Authority and reconvene as the Carver County Board. Motion carried unanimously.

Degler moved, Ische seconded, to open the public hearing on the environmental assessment for the County State Aid Highways 10 and 32 projects. Motion carried unanimously.

William Weckman, Public Works, explained the intent of the public hearing is for the public to comment on the completed environmental assessment. He stated when the project was started, it was determined that because of the scope of the project, that an environmental assessment would be needed. Weckman reviewed the process followed in completing the environmental assessment and the notices that were sent out.

Comments were received from the Met Council and Weckman reviewed the issues raised by the Council. Weckman stated the next step would be decide if an environmental impact statement is needed or if there is a finding of no significant impact.

No public testimony was received.

Weckman indicated he would address comments received and would be asking for a Board decision based on the comments next week.

Workman moved, Degler seconded, to close the public hearing. Motion carried unanimously.

Paul Moline, Land and Water Services, reviewed the request to install a second culvert in Baylor Park. He reviewed the proposed location and the petition received from landowners around Eagle Lake to investigate adding capacity to an outlet. He indicated there has been continuing issues related to the lake level and the DNR has been helpful in re-establishing what the high water level should be.

Moline stated the Board previously authorized that further technical investigation be done and explained the recommendation to add a second 36" culvert to reduce drawdown. He pointed out that one of the issues is vegetation near the outlet and an engineer had looked at the option of adding a standpipe in the area but did not feel the expense was warranted.

He noted they have not looked at the impact of the growth of the City over the last twenty years. Moline also pointed out many lakes are higher than normal because precipitation has increased.

Marty Walsh, Parks Department, suggested land owners may not see any appreciable difference in spring when there is typically more rain and snow melt. He noted the location and size of the previous culvert and replacement culvert currently located in the Park.

Moline indicated that the DNR was not in support of doing anything in the cattail area. He stated the goal is to hold water back rather than sending it downstream for water quality reasons.

Ische moved, Lynch seconded, to authorize the installation of a second culvert in Baylor Park to add overflow capacity in higher flows in an amount not to exceed \$5,000 with the cost to be taken from the Parks Department budget. Motion carried unanimously.

Degler moved, Delaney seconded, to adjourn the Regular Session at 9:55 a.m. Motion carried unanimously.

The Council provides the majority of the funding through a grant to the County and direct expenditures in support of project activities. The County will receive a total grant of \$8,000 for the 2006 & 2007 monitoring seasons. There is no match required. However County staff expends a couple hours per month on the site. The grant agreement and the grant funds are for a 2 year period: Jan 1 2006 through December 31, 2007. The majority of the funds will be used to offset intern costs.





OPENING STATEMENT

This Environmental Assessment Update and FONSI Request has been prepared and submitted in accordance with the approved Highway Project Development Process.

PROPOSED ACTION

There are no changes to the project location or description.

SOCIAL, ECONOMIC AND ENVIRONMENTAL IMPACTS

The following summarizes the information/findings/determinations presented in the EA; new information will be identified as such.

4(f)/6(f)

There will be no impact to 4(f) or 6(f) properties.

National Historic Preservation Act

A determination of No Historic Properties Adversely Impacted has been made by Mn/DOT Cultural Resources Unit and concurred in by SHPO.

Endangered Species

Per the USF&W and DNR there will be no impact.

Farmland Protection Policy Act

The project will not significantly impact farmland.

Air Quality

The project will not significantly impact air quality.

Noise

Noise impacts will be non significant.

4.347 acres of wetland will be filled.

Permanent acquisition 63.49 acres from 65 parcels is anticipated.

Environmental Justice

PROPOSED MITIGATION

The following summarizes the mitigation identified in the EA; revisions or new mitigation will be identified as such.

Curb and gutter will be used to minimize wetland impacts. The County has applied to the Board of Soil and Water Resources' Road Replacement Program to mitigate the impacted wetland area. Impact that is not covered by the Road Replacement Program will be purchased at a two to one ratio through the Minnesota Wetland Bank.

PUBLIC HEARING REQUIREMENTS

The Public Hearing was held Tuesday, March 14, 2006 at 9:15 a.m. Advertising for the Public Hearing was published in the Chaska Herald and the Waconia Patriot the weeks of February 9th and 16th, 2006. Additionally, a copy of the Public Hearing announcement was mailed to all property owners impacted by the project.

The Public Hearing was opened by the Carver County Board of Commissioners and Bill Weckman, Assistant County Engineer, summarized the project, went over the main points in the approved draft Environmental Assessment and addressed written comments received from the Metropolitan Council. The Public Hearing was open to the public for comment. No comments were received.

Commissioner Workman inquired about the safety of the curb design commented on by the Metropolitan Council. Bill Weckman replied that the alternate curb design would be looked at. Commissioner Degler inquired if there were any known turtle migratory paths along the project corridor. Bill Weckman replied that no known turtle migratory paths had been identified within the corridor.

Comments received and action taken:

- Metropolitan Council staff recommends that the project specify requiring utilization
 of surmountable curbs like MnDOT Curb and Gutter Design No. S524, or equal, to
 reduce the high mortality risk of turtles becoming trapped within the roadway while
 crossing between wetlands that have been dissected by the roadway. Carver County
 Public Works engineering staff is reviewing curb standards and verifying there are no
 turtle migratory paths identified within the project corridor.
- Metropolitan Council recommends clarification of what agency or agencies will have jurisdiction over proposed corridor wetland impacts and mitigation. This information can be found in Table 1 in the Environmental Assessment. Table 1 will be updated to clarify responsibilities.
- Metropolitan Council suggests that Public Works contacts Martin Walsh, Carver County Parks Director, to ensure the project is compatible with future trails. Martin Walsh has been contacted and is aware of the project corridor and the impacts within the corridor.
- Kent Torve, P.E. of Wenck Associates, Inc, on behalf of Carver County Planning and Zoning commented that Carver County should be listed for storm water and erosion control permit in Table 1 of the Environmental Assessment. Table 1 will be updated.
- Mr. Torve, acting on behalf of the County, requested that drainage area information, storm water management calculations, culvert sizing calculations, and ponding calculations be submitted to the County for review. Requested information is being gathered and will be submitted.
- Mr. Torve recommends using ditch blocks with draintiles/filtration trenches to achieve acceptable water quality standards and suggested using the typical detail found in the County guidelines.
- Mr. Torve recommends submitting erosion and sediment control plans to the County and the Soil and Water Conservation District. Plans have already been submitted for review.

RECOMMENDATION FOR FINDING OF NO SIGNIFICANT IMPACT

The proposed project is new construction of 0.7 miles of CSAH 32; constructed to two lane urban design standards; realignment and new construction of 1.7 miles of CSAH 10; reconstruction of 4.6 miles of existing two lane rural CSAH 10; all to current 2 lane urban and rural design standards.

The project was reviewed through the State Environmental Review Process of the Minnesota Environmental Quality Board (MEQB). The County Engineer has determined that the project meets a mandatory EAW threshold category and has prepared a combined EA/EAW. The EA/EAW was distributed by the County (the LGU) on February 8, 2006. The Carver County Board of Commissioners has issued a Record of Decision, based on Findings of Fact, that the project does not have the potential for significant environmental effects.

Based on the documentation of impacts in the EA/EAW, and the comments received in response to the public hearing and the public comment period, the County Engineer recommends that the Federal Highway Administration prepare a Finding Of No Significant Impact (FONSI) for this project.



The Metropolitan Council received the above noted Draft Environmental Assessment for the realignment and reconstruction of CSAH 10 from CR110 to 612' W of CSAH 11 and for CSAH 32 from 1320' E of TH284 to CSAH 10 on February 8, 2006. Council staff review finds that the EA is complete and accurate with respect to regional concerns and raises no major issues of consistency with Council policies. However, staff offers the following comments for your consideration.

Section III - Proposed Improvement - B. Design Standards

The draft document states that much of the western portion of the roadway will be updated from rural to an urban cross-section, with provision of curb and gutter. Thirty-four wetlands are either within or near the project corridor. Typical roadway section Figure 5 indicates that 'B424 Curbing' is proposed to be utilized within the portions of the new roadway that will utilize curb and gutter. Due to the significant number and acreage of wetlands along both sides of the roadway, Council staff recommends that the project specify requiring utilization of surmountable curbs like Minnesota Department of Transportation Curb and Gutter Design No. S524, or equal. This more gently sloping curb design would reduce the high mortality risk of turtles becoming trapped within the roadway while crossing between wetlands that have been dissected by the roadway, without impacting storm water flow or driver safety.

Section VI - Public and Agency Involvement - B. Permits and Approvals

The draft document needs to more specifically address what permits will be necessary in advance of planned impacts to 4.35 acres of wetland along the project corridor. The final document text and Table 1 need to clarify what agency or agencies (including Carver County Planning and Zoning, Minnesota Department of Natural Resources, U.S. Corps of Engineers, in addition to the Minnesota Pollution Control Agency) will have jurisdiction over proposed project corridor wetland impacts and mitigation.

Section VII - Environmental Study - A. Section 4(f) Park and Recreational Property

This project would cross the proposed Twin Cities and Western Regional Trail as well as the Carver North/South Regional trail search corridor. On behalf of Carver County Planning and Zoning, I have reviewed the EA dated January 24, 2006 and draft plans including the wetland delineation and impact figures and have the following comments:

Permits and Approvals

 Carver County should be listed for storm water and erosion control permit in Table 1 on page 13.

Drainage Areas

- The project involves very large drainage areas, and storm water management calculations should provide sufficient detail for adequate review.
- Information provided for storm water management should include potential upstream and downstream impacts (not limited to the roadway area itself).
- Information should be submitted that documents the location and dimensions of any increasing the diameter of existing culverts. Justification should also be provided.

Ponding Areas

The Environmental Assessment (Page 20) documents storm water facilities are planned for the project. Calculations should be submitted for review.

Water Quality

 Water quality treatment is a challenge for linear projects. A recommended approach is ditch blocks with draintile/filtration trenches. The County guidelines provide a typical detail that can be utilized for transportation projects.

Erosion Control

 Details are given in the draft plan sheets for methods of erosion control. A full review of the final erosion control plan should be performed by SWCD.

EXPLANATION OF AGENDA ITEM (Include a description of background, benefits and recommendations)

Staff recommends the County contract with Wold Architects and Engineers to lay-out location options, design alternatives and deliver to the County a set of drawings which will allow the renovation of existing space in the Justice Center to accommodate a temporary non-jury courtroom until such time a more permanent Courtroom solution can be provided.

A Temporary Courtroom Taskforce has been formed and has been tasked with reviewing location and design options. After two meetings, the recommendation is to renovate the current Jury Assembly room and turn it into a fourth courtroom. To date, Judge Kanning, Judge Eide, Judge Davies, Carol Renn, Jeff Enevold, Kari Myrold and Bob Darnell have provided useful input into this process.

As this is a temporary solution, Wold will provide the County options on suitable ways to furnish the courtroom while providing appropriate judicial design and decorum. Attachment 1 depicts a conceptual plan for what the temporary courtroom might look like.

In concert with these changes, we will be reviewing the possibility of relocating part of the Law Library whereby a set of annotated statute books, Municipal volumes, Attorney General Opinions, and a limited number of other legal resources as well as three computer terminals will be housed in the Courthouse while the bulk of the existing Law Library materials will be transferred to the Chanhassen Library. The Courthouse Law Library would also be reduced in size to accommodate future staffing growth. The benefits of this relocation include:

- The Law Library space at the Courthouse will be reduced significantly in size possibly allowing the County Attorney to migrate into this area as their staff grows
- Having the primary Law Library at the Chanhassen Library will allow greater access to the collection due to weekend and evening hours
- By housing the Law Librarian at the Chanhassen Library, this position can assist with other Library public education service priorities.

Further discussion will have to take place to determine the feasibility of this proposal.

Wold's deliverables will include construction drawings, a construction estimate and a detailed construction schedule. The schedule as we know it today has construction being completed by September 1, 2006.

Attachment 2 outlines the proposed scope of work with a fixed fee of \$22,000 for Wold design efforts and a not-to-exceed of \$500 for reimbursables (mileage and printing costs). These costs include:



Based on our meeting on February 14, 2006 we have put together the following preliminary scope description:

Develop design options to accommodate a temporary non-jury courtroom. One possible location is the current jury assembly room.

The following concerns were noted:

- Appropriateness of space and furnishings for a courtroom.
- Security including card reader access.
- Utilize ITV room as judge's chamber relocating ITV room.
- Access to mechanical penthouse.
- ADA requirements.

Fee:

Since the scope is still not finalized I propose that we begin work on an assumed fixed fee of \$22,000, which will be reviewed and adjusted as necessary when the option and scope are finalized.

ORDER AUTHORIZING EXTENSION OF TIME TO COMPLETE PRELIMINARY SURVEY BY ENGINEER APPOINTED BY DITCH AUTHORITY ON DECEMBER 13, 2005.

In the Matter of the Petition of Travis and Sara Gulbranson, Robert Dalchow, Andrew and Bonnie Melville for the Establishment and Construction of a lateral to Carver County Ditch #9 in the County of Carver, State of Minnesota.

Whereas, on December 13, 2005, the Carver County Board of Commissioners, acting as the drainage authority for Carver County Ditch #9, appointed Steve Klein of Barr Engineering as engineer in this ditch proceeding and that said engineer make a preliminary survey of the area likely to be affected by the proposed tile lateral, examine all matters set forth in the petition and file his report, as to the necessity for, and the feasibility of, constructing the proposed tile lateral, with the County Auditor of Carver County, on or before the 1st day of April, 2006.

Whereas, the Carver County Attorney was informed on March 3, 2006, that Steve Klein of Barr Engineering will need until May 15, 2006 to complete the preliminary survey. Steve Klein has also requested reasonable access over all the parcels of land that the proposed tile line would traverse so as to ensure the accuracy and quality of the preliminary survey.

NOW THEREFORE, It is ordered that Steve Klein of Barr Engineering shall have until May 15, 2006 to complete his preliminary survey of the area likely to be affected by the proposed tile lateral, examine all matters set forth in the petition and file his report, as to the necessity for, and the feasibility of, constructing the proposed title lateral, with the County Auditor of Carver County. IT IS ALSO ORDERED that Steve Klein and any other employee of Barr Engineering or its agents shall have reasonable access over all the parcels of land that the proposed tile line would traverse so as to ensure the accuracy and quality of the preliminary survey. This right of entry is pursuant to Minnesota Statute section 103E.061.

All other terms and conditions of the Order signed by James Ische, Chair, Carver County Board of Commissioners, acting as the drainage authority for Carver County Ditch #9 on December 13, 2005 shall remain in full force and effect.
