#### **SYNOPSIS:**

On 4/21/2016 at about 0943 hours, sheriff's deputies were dispatched to a medical call at Paisley Park 7801 Audubon Dr., Chanhassen, MN. Sheriff's deputies and emergency personnel from Chanhassen Fire and Ridgeview Ambulance arrived at about 0948 hours and found an unresponsive adult male in the elevator. They tried to provide lifesaving CPR, but were unable to revive the victim. He was pronounced deceased at 1007 hours. He has been identified as Prince Rogers Nelson (57) of Chanhassen.
